Blue Fish

I am uncomfortable with the church's policies on homosexuality. One or more of these statements may describe your view or belief:

- 1. Scripture is the inspired word of God and is to be understood and interpreted within the culture and times of the people who lived during biblical times.
- 2. Human sexuality including homosexuality is a gift from God.
- 3. Marriage may be between two people of the same gender.
- 4. I want the church's polices to change and will be concerned and may consider leaving if the church does not change its policies.

Present the legislation with one speech for and one speech

The six pieces of legislation will be presented at the same time.

- 1. The first four pieces of legislation seek to change the Discipline and the church's policies about homosexuality. These pieces will be presented by the writer of the legislation who will have three minutes to speak. Someone who opposes the legislation will also have three minutes to speak.
- 2. The remaining two pieces of legislation call for the conference to commit and work for 1) the full civil and ecclesiastical rights of lesbians, gays, bisexual and transgendered persons and 2) support marriage equality. This will be presented by the writer of the legislation who will have three minutes to speak. Someone who opposes the legislation will also have three minutes to speak.
- 3. There will not be an opportunity to amend the legislation or ask questions about the legislation. A Frequently Asked Question (FAQ) page has been added to the legislation pages of the website. Transition moment:

Begin with silence and then sing, "Lord Listen to Your Children Praying".

Engage in holy conferencing with a sharing partner: During a 20 minute period, sharing partners will introduce themselves to each other and share the answers to the following questions:

- 1. How has your life been touched by God, in the last year or while at Annual Conference?
- 2. What is your hope for the future of the church and what concerns do you have?
- 3. How have you personally experienced the churches struggle with homosexuality?
- 4. The sharing partner asks one question for clarification, for example: "Share with me more about ... and why you believe this." Or, "How did you come to this understanding?" Or, "How would you see GNJ living this out?" Or, "What experience did you have

that shaped your thinking?"

- 5. What do you believe about the church's policies concerning homosexuality and what do you want others to understand? 6. The sharing partner asks one question for clarification, for example: "Share with me more about ... and why you believe this." Or, "How did you come to this understanding?" Or, "How would you see GNJ living this out?" Or, "What experience did
- 7. What is one thing that would help me know you better if I understood it about you?

Vote by paper ballot:

you have that shaped your thinking?"

People will vote yes or no for each of the six pieces of legislation on a single paper ballot.

The ballot:

Numbers 1 through 4 petition General Conference to change the prohibitive homosexual language in the Book of Discipline. Numbers 5 and 6 call for Greater New Jersey to support an action for full inclusion of LGBT people and marriage equality.

1. Strike from the Book of Discipline the phrase we do not condone the practice of homosexuality and consider the practice incompatible with Christian teaching.

2. Strike from the Book of Discipline the phrase Ceremonies that celebrate homosexual unions shall not be conducted by our ministers and shall not be conducted in our churches.

3. Strike from the Book of Discipline that homosexuality and performing homosexual unions or weddings is a chargeable offense.

4. Strike from the Book of Discipline that United Methodist funds cannot support the acceptance of homosexuality or support homosexual ministries.

Sister and Brother Members of the Greater New Jersey **Annual Conference,**

Over the next few weeks, I will share with you important information about our Annual Conference Session, May 28-30 in Wildwood, N.J. Our theme is FISH and what it means for us to FISH on the other side. I will be writing to you to share information about how we will engage in:

- 1. Homosexuality legislation (the subject of this email)
- 2. Balloting for General and Jurisdictional Delegates
- 3. Additional legislation and nominations that were not included in the initial pre-conference journal and handbook.

The church is blessed by God with disciples who disagree. God created us and gifted us with different cultures, races, and experiences. From these differences we naturally have ideas that grow out of our individual experiences. Paul and Peter differed in belief and practice of ministry because their calling and experiences were different. Paul focused on the Gentiles and Peter on the Jews which led to different understandings of diets, worship and rites like circumcision. I look forward to seeing you while we worship, learn and engage in the matters of the church. Keep the faith!





process outlined below because:

- 1. I care about our relationship with God and one another and see relationships as primary in the midst of difficult issues.
- 2. Debate very rarely changes a person's view point.
- 3. I want us to continue to understand and experience that we can disagree without doing harm to one another, the church and our witness of Christ in the world.
- 4. I want us to shape our decisions and life together through prayer, singing, conversation and Holy Spirit discernment.

At Annual Conference, I will follow this process:

- 1. Outline the process for how we will engage the legislation on homosexuality and solicit your support.
- 2. Share an overview of the United Methodist Church policies concerning homosexuality.
- 3. Assist people to identify a sharing partner.
- 4. Present the legislation with one speech for and one speech against.
- 5. Engage in holy conferencing with a sharing partner.
- 6. Vote by paper ballot.

Share an overview of the United Methodist Church policies concerning homosexuality:

- 1. We are not to ordain and appoint self-avowed, practicing homosexuals.
- 2. Our pastors are not to perform marriage or holy union ceremonies for same gender couples nor are they to be conducted in our churches.
- 3. The church is not to spend money to promote homosexuality and when homosexuality is discussed, the church's view is to be shared.

Assist people to identify a sharing partner: Members will be asked to identify a sharing partner with someone who has a different view than their own concerning homosexuality. Each person's view point will be identified as a different type of "fish", building on the Annual Conference theme. Members will select their "fish" by identifying with one of three viewpoints listed below:

Striped Bass Fish

I am comfortable with the church's policies on homosexuality.

One or more of these statements may describe your view or belief:

- 1. Scripture is authoritative and is to be followed as it is written.
- 2. God created humanity to be heterosexual not homosexual.
- 3. Marriage should be between a man and a woman.
- 4. I want the church's policies to continue and will be concerned and may consider leaving if the church changes its policies concerning homosexuality.

I have views that are moderate, not fully shaped or are in the middle of different viewpoints. I am willing to compromise so that varying views are affirmed.

One or more of these statements may describe your view or belief:

- 1. I do not feel qualified to judge any person's heart to decide whether they are good or bad in God's sight.
- 2. I understand that God's grace and love extends to all and I try to accept all people without reservation or judgment.
- 3. I am in agreement with our church's policies on homosexuality, but I experience important understandings with those who have a different view.
- 5. My view point is still being shaped about homosexuality
- 6. I will stay within the United Methodist Church if the policies change
- 7. I will stay within the United Methodist Church if the policies do not change
- 8. I am still trying to understand how to interpret scripture concerning homosexuality
